Ben Lohman Gun Club Several years on Board of Directors, organized finances and worked with the board to find and purchase 560 acre facility before the club lost its lease PSAC (Practical Shooting Association of Colorado) the IPSC club that hosted the first Nationals

President and Board of directors for 5 years in the mid 1980's

Youth Shooting

Assistant junior pistol coach at USOC gun club in Colorado Springs
Trained as a Class C coach in international style pistol shooting

Scout Master of a Boy Scout troop who's Chartered Partner was a gun club (the only troop sponsored by a gun club in the country)

Organized with Massad Ayoob in 1999 a separate category for junior shooters firearm prizes for all junior participants at Second Chance Combat Shoot

Law Enforcement

Colorado POST certified as a firearms instructor for nearly 15 years at Douglas County Sheriff's

Department in Colorado for handgun, shotgun, rifle, submachine gun and tactics. Certification required completion of separate approved skill courses in each area.

Shooting Activities

Been an ICORE for the past 5+ years and have competed in the IRC for the past 5 years

On the Colorado IPSC Nationals team for a number of years starting in 1979 shooting the Natl's in VA, TX, AZ, Milan IL and once in Berry IL

Competed in the IPSC World Championship in Hampton VA

Won the Canadian IPSC National Championship Match in BC in 1982

Won Handgun Master at Second Chance in 1991 using a revolver, won Al's Snubby revolver event in 1996 against all comers

Master class PPC shooter

Steel Challenge competitor since the early 80's

Attended Bianchi Cup a few times back when we got engraved invitations from John B himself

Held Expert or higher classifications since the mid 70's in Bull's-eye indoor & outdoor, high power rifle, NRA rim fire silhouette, International 10M air pistol, 25M standard pistol, 25M center fire pistol

I am Ron Williamson. Member and Statistician since ICORE's inception. First Life member of ICORE. Has participated in 19 IRCs and been IRC Statistician since 2001.



My name is Vic Pickett and I currently hold the position of Match Series Director on the ICORE Board of Directors. I am asking for your vote so I can continue to serve the ICORE membership and the Board of Directors for the next 2 year term of 2012 & 2013.

The Match Series Director's responsibility is to promote, oversee and support the ICORE Regional matches held annually in the 9 regions of ICORE, including Australia & Europe. And assisting the host clubs setting match dates, locations, & times. Also

overseeing that Prize Guns, Certificates and any promotional materials are sent to Regional Match Directors. ICORE Bylaws state that the MSD (Match Series Director) has the responsibility of acting as liaison between ICORE and the major sponsor of the Regional Match Series.

In 1998 I was appointed to the newly formed ICORE Board of Directors as Match Series Director. Prior to my appointment Ken Jorgenson from Smith & Wesson, and I drafted a formal plan for ICORE to hold a series of ICORE Regional Championships. The concept was discussed in the past and with the support of Ken from Smith & Wesson and the California Wheelburners it became a reality. S&W would be the major sponsor for the series, along with other companies in the gun and accessories industry offering their support. Since that time I have maintained the position of MSD on the ICORE Board.

Two years ago while running for MSD in the 2010-2011 elections, I listed some items in my resume that I would like to see implemented. Below are items from my list and a status update as to what was accomplished by the ICORE Board of Directors in my last 2 year term. I am pleased with the progress ICORE has made, but there is more work that can be done to improve the organization.

Items that I wanted to see in my last 2 year term.

- *An additional European Region formed. ICORE now has a European Region headquartered in Italy.
- *Greater support for ICORE Australia. ICORE USA paid for renewing ICORE Australia's Mandatory Liability insurance 2010 &2011.
- *Additional ICORE support for all the Regional Championships.
 ICORE gave direct support to the Regional Championships by providing cash "Money Plaques."
- *More incentives for Junior shooters.

 Recommended ICORE clubs to allow Juniors under 16 to shoot for free if finances would allow it.
- *An additional Board position of Press/Media/Advertising Director.
 Did not add a BOD position, but had a BOD member(s) acting as a Media contact in 2010-2011.
- *To complete and implement a Range Officer Program.

 Not implemented but ICORE recently appointed someone to act as Manager/Chairman of a Range Officer Program. Program pending BOD approval.

2012 & 2013

In the next 2 year term, I would support some changes to help ICORE grow and continue to being the leader when it comes to promoting safe, fun, revolver competition.

I would like to see:

- *ICORE State Championships.
- *More incentives for new ICORE clubs to be formed.
- *Better content for our Cylinder Turns Newsletter.
- *Allow .22 cal rimfire revolvers to participate for fun at club level matches only. Match Directors final decision. Draft simple guidelines to address scoring concerns and knock down steel.
